Dear John:

Public Employees Local 71 is pleased to announce the 2016 nomination meeting for the election of the Officers of Public Employees Local 71, the Delegates to the Alaska District Council of Laborers and the Delegates to the LiUNA Convention. Officers and District Council Delegates serve a four (4) year term.

Nominations will be for the following positions: President/Convention Delegate, Vice President, Recording Secretary, Business Manager/Secretary-Treasurer/Convention Delegate/District Council Delegate, Sergeant-at-Arms, Auditors (3), Executive Board Members (3) and Delegates to the District Council (4). The salary and compensation to be paid elected officers shall be fixed at the nominations meeting prior to nominations.

Additionally, this year, Local 71 is allowed seven (7) delegates to the LIUNA International Convention in Las Vegas in September, 2016. Because the Local's elected Business Manager/Secretary-Treasurer/Convention Delegate/District Council Delegate and Executive Board President will serve as Convention Delegates, the Local is entitled to elect five (5) additional Convention Delegates.

Delegates will be flown to Las Vegas and housed in a hotel by LIUNA. They will be paid by Union Business Leave for the week they are in Las Vegas. One hundred fifty dollars (\$150.00) per day will be allotted as per diem for meals and incidental expenses over and above the LIUNA grant.

The nominating meeting will be in Anchorage at the Local 341 hall at 2501 Commercial Drive at 12:00 p.m. on April 30, 2016.

Nominating Rules:

- 1. The Nomination Meeting will begin promptly at 12:00 p.m.
- 2. Please arrive early to ensure you arrive in time to nominate and/or to be nominated.
- 3. Nominations will be made in order by office.
- 4. Nominations must be made by another member in good standing and must be seconded by another member in good standing either in person or by certified, registered, or express mail to be received by close of business April 29, 2016.

- 5. Nominees must be members in good standing for two years and working at the calling for one year prior to the nomination meeting.
- 6. Nominees must be declared eligible within 72 hours of the nomination meeting.
- 7. Full contact information for both Nominator and Nominated must be included in order that either may be contacted to verify qualifications.
- 8. Candidates are required to meet with the Judges of the Election immediately after the nomination meeting on April 30, 2016, unless excused and rescheduled per Article VI, to determine whether each candidate possesses all the qualifications set forth in Article V of the Local Union Constitution.
- 9. Candidates should bring identification proving their lawful permanent residence under Local Union Constitution Article V, such as your birth certificate, passport, green card or naturalization certificate.

If more people are nominated and accept the nomination for office/delegate than there are vacancies, the election of any contested office and/or convention delegates will take place by mail ballot. Only members in good standing as of the date of the Election will be eligible to vote, so if you are unsure of your membership status, please call (907) 276-7211 Anchorage, (907) 452-5024 Fairbanks, or (907) 586-6993 Juneau to verify that you are a member in good standing.

Please plan to attend the nomination meeting and participate in this important union activity.
